What a pleasure and honor to be a breeder judge at a National Specialty Show. I do thank the membership for the opportunity. And, what a start by judging the 4 – 6 month old puppy class. They certainly did entertain everyone. Super temperaments and general over all look, certainly pointing to a good future for our breed.

When judging one's own breed, it is always in your mind, "what would I take home"! As I looked at my three top winners, I felt the decision was easy. All three, BOB (GCH Karisma Heart and Soul), BOW (Sunset's Have Gun Will Travel – not helping his owner when his picture was taken – we all know they can do this to us), BOS (GCH Mariblu Forevermore at Safire) were of good breed type, having a nice outline, proper coat and good color. A nice dark face with light topknot, dark eyes, nicely shaped ears and head. As I look at their photos in the last newsletter, it's so apparent the consistency of proper type. I would be remiss if I did not mention the very nice young bitch (CH. Tumbelle' N Silkyence Eye Candy) that was awarded Select Bitch and an Award of Merit. Any breeders dream and one to watch! The RWD (Blufire Power Play) and RWB (RHK Isabella Catale) are certainly also on the list to watch. And a few others demanded my consideration, which was great.

The other Select and Awards of Merit were GCH. Wind Dancer Jenstar Backstage Pass (a real handful for his handler that day), and the Veteran Dog, GCH Mtnview Prince Chbaka Ekruro.

The Best Puppy, Mariblu Just One More at Safire was wonderful and was pushing for Reserve Winner Dog. He just has to mature into his shortness of leg which is age related. It will be fun to watch him mature.

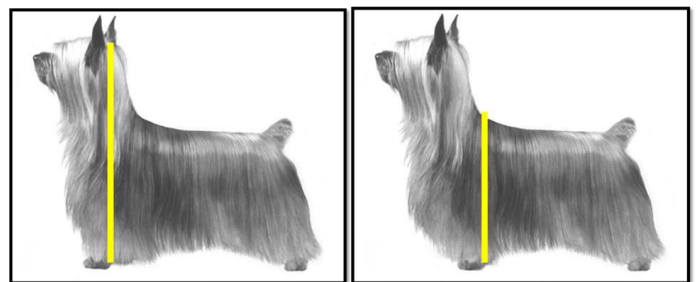
I'm always reminded of Annie Clark when judging, saying, "first select those typical specimens of the breed and then reward the soundest of those". This is what I tried to do!

As for concerns that day, most coats were of good texture, but a few were not. There were two that had Yellow in their eyes which is a severe fault in our breed. The over-all problem is in the front angulation. Being straighter in the upper arm, puts the legs under the head instead of under the withers. Not only does this affect the over-all balance, but makes the dog appear longer than it should or is. I was asked about this statement after the dinner and decided to attach a copy of one of our slides used in our Breed Education CD. Look where the front feet are!

The illustration shows how the same dog can appear too long due to the upper arm being too straight. Yet the shoulder is well laid back, as called for in the standard. Additional nominations may be made in accordance with Article V, Section 1(c) of the Bylaws, "Additional nominations of eligible members may be made by written petition to the Secretary at his/her regular address and postmarked no later than November 1st, with a brief resume of each nominee's qualifications, signed by five (5) members in good standing and endorsed by each such additional nominee signifying their willingness to be a candidate. Additional nominations, which are provided for herein, may be made only from among those members who were not nominated by the Nominating Committee or declined a nomination as above provided, and must be a member of STCA for three years (3) years prior to petition. No person who has declined the Committee's nomination may be nominated by petition for the same position. No person shall be a candidate for more than one position".

Article V, Section 1(d), "Nominations cannot be made in any manner other than as provided in Article V, Section 1 above."

If no valid additional nominations are received by the Secretary postmarked on or before November 1st, the Nominating Committee's slate shall be declared elected and no balloting will be required.

Newly elected directors will officially take office Feb. 1st of each year after election.
