PLEASE READ IMPORTANT - Announcements to Membership

ROM & ROMX CERTIFICATES must be **REQUESTED** by a dog's owner starting with 2013. In the past someone has kept the records by taking information from AKC Gazette and placing on cards. This method was originated by Peggy Smith when there were maybe 10 - 12 new champions each year. This meant someone had to go thru monthly to make notes on cards for every dog finished. Then annual check these cards to see who was eligible. This has become an enormous responsibility and very time consuming and mistakes are easily made. Starting with all dogs eligible for ROM or ROMX in 2013 you must 'REQUEST' a certificate and send in the AKC report showing the number of Champions produced by your dog or bitch. As Responsible Breeders we should be proud of our dogs accomplishments and know our dogs statistics and not depend on someone else. This is easily obtainable on the AKC Website for \$5.00 report fee. This report should be submitted along with request for either ROM or ROMX certificate to the Vice President of the Club - currently Diane Angeli - dianeangeli2183@gmail.com. There will be a reminder in the Newsletter in Jan/Feb.

Jr. Showman are also responsible for sending request and reports of accomplishments each year to the Jr. Showman Coordinator. There will be reminder in Jan/Feb Newsletters. If you have questions, need information on requirements or forms to be filled out, please contact the Jr. Showman Coordinator - it is your responsibility and a part of your 'training' to keep proper records. 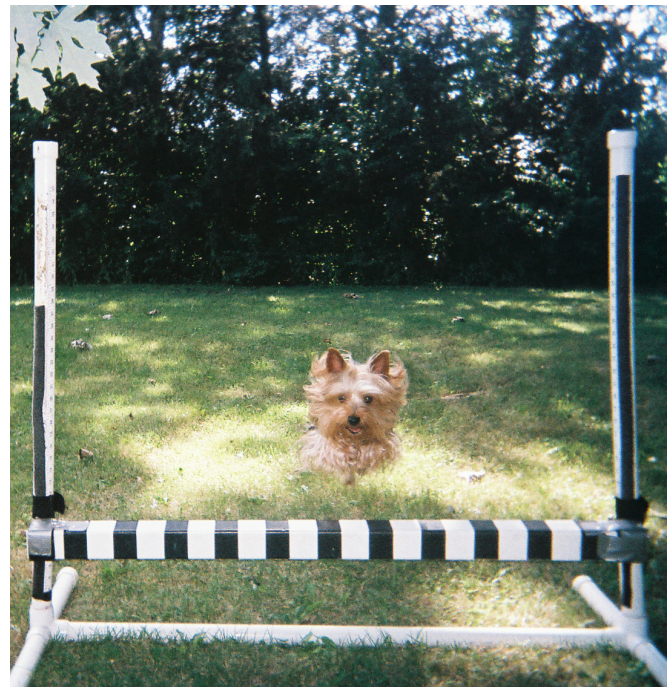
